

**Rev It Up Sweepstakes
Enter to Win A Car Prize
Bloodworks Official Rules**

NO PAYMENT OR PURCHASE OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PAYMENT OR PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. The **Rev It Up Sweepstakes** (“Sweepstakes”) is a promotional giveaway designed to encourage and incentivize first time and lifetime donors to donate blood with Bloodworks at any of its Donor Centers or any Bloodworks area mobile collection site between December 28, 2020 – March 17, 2021. ENTRANTS MUST BE 18 YEARS OF AGE OR OLDER AT THE TIME OF ENTRY TO ENTER THE SWEEPSTAKES. The Sweepstakes is sponsored by Bloodworks (herein “Sponsor” or “Bloodworks”) with the principal place of the organization located at 921 Terry Avenue, Seattle, WA 98104. Sponsor will randomly select winners, as defined herein, and prizes, as defined herein, will be awarded in accordance with these Official Rules. **The Rev It Up Sweepstakes IS MADE POSSIBLE BY PARTNERSHIP OF BLOODWORKS AND HASELWOOD AUTO GROUP FOR THE SOLE PURPOSES OF SAID SWEEPSTAKES. For the avoidance of doubt, Bloodworks and Haselwood Auto Group are independent entities and the Sweepstakes is not intended to make a joint partnership or otherwise, other than two entities collaborating for the purposes of a Sweepstakes in promotion of Bloodworks.**

1. Eligibility: In order to be eligible to participate in the Sweepstakes one must agree to be bound by these Official Rules which constitute a binding agreement. Participation in the Sweepstakes are optional and available for persons registering to donate at a Bloodworks Donor Center or any Bloodworks area mobile collection site between December 28, 2020 – March 17, 2021, Sweepstakes are open to legal residents of Washington or Oregon who are eighteen (18) years of age at the time of entry or older, each person within this category shall be referred to herein as an “Entrant” or “Participant.” Individuals are not authorized to participate in this Sweepstakes if they are not a legal resident of either Washington or Oregon. Employee of Bloodworks or Haselwood Auto Group and all other companies, partners, advertising and promotion agencies associated with the design or execution of the Sweepstakes are ineligible to enter the Sweepstakes. For the avoidance of doubt, there may be regulations concerning the amount of donations a person is able to donate with Bloodworks, thus Bloodworks reserves the right to limit multiple entries by Participants wanting to donate more than once during the “Sweepstakes Period,” as defined below. Furthermore, Bloodworks reserves the right to deny additional registration attempts. Other restrictions may apply; please consult with Bloodworks for other eligibility restrictions. Bloodworks is not treating or dispensing medical advice to any donor in connection with their participation in the Sweepstakes. Sweepstakes will be void where prohibited by law.

2. How to enter: All donors that register to donate at a Bloodworks Donor Center or any Bloodworks area mobile collection site during the dates of December 28, 2020 – March 17, 2021 (“Sweepstakes Period”), will be automatically entered in the Sweepstakes, provided such persons meet the eligibility requirements as noted herein. All Entrants in the Sweepstakes can opt out of participating in the Sweepstakes at any time by contacting Bloodworks and informing a Bloodworks representative or declining the “Prize” (defined below) if contacted by Bloodworks as a Winner. Bloodworks will ensure any persons not wanting to participate will be removed from the Sweepstakes. Donors will be eligible to receive one (1) entry for each donation during the Sweepstakes Period, restrictions on numbers of entries a person is able to make regarding the Sweepstakes may apply, please contact Bloodworks for any applicable restrictions health-related or otherwise, as there are restrictions for blood donations and type (including, but not limited to, apheresis or whole blood) in a specified period of time. All Entrants entered in the Sweepstakes must abide by these Official Rules (the “Official Rules”) to be eligible to win the Prize, and agree to comply with all federal, state and local laws and regulations concerning the Sweepstakes. *Bonus Entry Potential:* Bloodworks reserves the right at its discretion to add entries for Participants (or other additional incentives to promote participation in the Sweepstakes), such as double-entries for Participants that bring to

Bloodworks registrants for donation, i.e., a friend or relative to register to donate with Bloodworks. Any promotion revisions to these Official Rules regarding the aforesaid or the like, Bloodworks will publicly post on its website and other public outlets, including, but not limited to, social media platforms, any addendums to the Official Rules to ensure the public is duly notified. Entrants who do not provide complete, valid, and truthful registration information will not be eligible to win. Once registration is completed to the satisfaction of Bloodworks, the Entrant will be entered into the Sweepstakes as per these Official Rules. Limit one (1) entry per donation throughout the Sweepstakes Period, unless otherwise accepted by Bloodworks through additional options added to the Official Rules. Any potential "Winner", i.e., a person who wins a Prize, may be requested to provide Bloodworks with proof that such Winner is a legal resident of Washington or Oregon. Each Winner must agree to the Bloodworks use of his or her name, likeness, photograph, picture, portrait, voice, media interview or other interview, biographical information and/or any statements made by Winner regarding the Sweepstakes without additional compensation, obligation, or notice, for the purposes of publicity and promotion, worldwide and in perpetuity, in any and all forms of media, now known and hereafter devised, including, without limitation on-line.

3. Prizes and odds of winning (Prizes are valued as listed): There will be one (1) Prize Winner total in the Sweepstakes. One Winner will receive ONE (1) new automobile valued at approximately MSRP of \$21,605.00 to \$25,060.00 USD (the "Prize"), depending upon the year, make, model, and trim package of the vehicles. The Prize will be pre-selected at the discretion of Bloodworks and Haselwood Auto Group from nine (9) vehicles for the Winner to choose from, and is not reversible by the Winner after the selection is made and the vehicle is in possession of the Winner. Winner may not redeem the Prize for cash, but may potentially use the amount of the Prize to purchase an upgraded vehicle pending Haselwood Auto Group approval and other credit restrictions may apply, including, but not limited to, financing if pursued by Winner. Other automobile dealership rules and restrictions may apply from Haselwood Auto Group. Haselwood Auto Group will pre-select with Sponsor, vehicle make, model, and trim package, or other automobile attributes that will comprise the Prize. Color selection of the vehicles made available for Winner to choose from will be according to the color availability from the Haselwood Auto Group inventory at the time of Prize redemption by the Winner and will be coordinated with Sponsor regarding date and time after the close of the Sweepstakes for the Winner to make their selection from the nine (9) options made available per the conditions of these Official Rules. Odds and chances of winning a Prize are based upon the number of eligible entries received with all Entrants having an equal chance of winning; Winners will be selected randomly as noted below. All other costs and expenses in connection with Prize, including but not limited to, licensing, receipts and use of the Prize, are the sole responsibility of the Winner other than as detailed below regarding Taxes. The Prize is not transferable and must be accepted as awarded by Bloodworks unless otherwise agreed. Bloodworks reserves the right, in its absolute and sole discretion, to make a substitution of a prize, to serve as the Prize, provided it is of equivalent kind or approximate value in the event of the unavailability of the Prize for any reason beyond the control of Sponsor. Winner will be publicly revealed March 31, 2021 by Bloodworks. The Winner must collect the Prize from Haselwood Auto Group, 1100 Oyster Bay Ave S., Bremerton, WA 98312. Prize will not be shipped to Winner. Winner must respond to Bloodworks within forty-eight (48) hours of contact by Bloodworks to claim the Prize or Winner will forfeit any claim to the Prize per Section 6 herein.

4. Fees. Winner agrees they will be financially responsible for costs related to tax, license, and title of the Prize ("Fees") based on MSRP of vehicle selected. Due to the cost of the Prize and the potential burden of Fees placed upon the Winner, Haselwood agrees to offer the Winner financing options for such Fees at a reasonable price to the Winner. Haselwood agrees to work in good faith any financing options made available with the Winner or their representative, based upon sensible credit approval standards customary for the automobile industry.

5. Acceptance of the Prize. Winner shall have forty-eight (48) hours from the time Bloodworks has placed a notification phone call and/or from the time Bloodworks has sent a notification email to respond to Bloodworks and accept their Prize with proof of identification, or, at Bloodworks' option, Bloodworks will

begin the process of randomly selecting an alternative winner, with the same random selection process as is noted herein.

6. Conditions; RELEASE: (a) The Winner is not required to have a valid Driver's License and Proof of current insurance applicable with Washington State law provisions in order to win the Prize, but they are required to have the driver that takes possession of the Prize from Haselwood Auto Group to have the following: Valid Driver's License, Proof of Insurance in order to lawfully drive the vehicle off of the Haselwood Auto Group property; (b) Winner will be responsible for any federal, state and local tax liability unless otherwise noted herein and must upon request provide Bloodworks with their social security number and any other applicable information for the purpose of preparing IRS Form 1099; (c) Bloodworks will use all commercially reasonable efforts to protect the confidential information of Winner; (d) Winner must sign a release form as prepared and accepted by Bloodworks acknowledging his or her acceptance and understanding of these Official Rules, releasing Bloodworks from any and all liability, claims or actions related to this Sweepstakes and the Prize, and indemnifying Bloodworks for any loss, damages or injury associated with accepting or using the Prize; (e) By participating in the Sweepstakes, all participants agree to release, discharge, and hold harmless Bloodworks, affiliates, subsidiaries, advertising and promotion agencies, and other individuals engaged in the development or execution of this Sweepstakes, from any liability, claims, losses, and damages arising out of or relating to their participation in this Sweepstakes or the acceptance, use, misuse, or possession of any Prize received in this Sweepstakes; Bloodworks reserves the right to make changes in the Official Rules of the Sweepstakes with proper notification to Entrants, including, without limitation, the substitution of a prize of equivalent value and similarity, which will become effective upon announcement/notification; (f) The Sponsor of the Sweepstakes is not responsible for typographical or other errors in the printing of the Sweepstakes, offering of the administration of the Sweepstakes, or in the announcement of the Prize; (g) All Entrants agree to comply with and be bound by decisions of Sponsor, which shall be final and binding in all respects. To the extent permitted by law, the rights to litigate, to seek injunctive relief from or in connection with this Sweepstakes, are hereby excluded and Entrants expressly waive any and all such rights.

7. Applicable Law, Arbitration: This Sweepstakes shall be governed by and construed in accordance with the laws of the state of Washington regardless of the principles of conflicts of laws. All federal, state and local laws and regulations apply. Any action or litigation concerning the Sweepstakes shall take place exclusively in the federal or state courts of Seattle, Washington, and as per below. Each Entrant expressly consents to the jurisdiction and venue in such courts and waives all defenses relating to jurisdiction or venue. The Sweepstakes are sponsored by Bloodworks as a giveaway of chance. Arbitration shall proceed solely on an individual basis without the right for any claim to be arbitrated on a class action basis or on bases involving claims brought in a purported representative capacity on behalf of others. The arbitrator's authority to resolve and make written awards is limited to claims between Entrant and Bloodworks alone. Claims may not be joined or consolidated unless agreed to in writing by all parties. No arbitration award or decision will have any preclusive effect as to issues or claims in any dispute with anyone who is not a named party to the arbitration. Notwithstanding any other provision in these Official Rules, and without waiving either party's right of appeal, if any portion of this class action waiver provision is deemed invalid or unenforceable, then the entire Arbitration clause (other than this sentence) shall not apply.

TO THE EXTENT PERMITTED BY WASHINGTON LAW, BY ENTERING THE SWEEPSTAKES.
