

Bloodworks Blood Donor May Giveaway 2024 – 1,000 Donors, 1,000 Thank Yous, \$1,000 Gift Card

Bloodworks Official Rules

NO PAYMENT OR PURCHASE OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PAYMENT OR PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. The Bloodworks Blood Donor May 2024 - Enter to Win a \$1,000 Spa Gift Card (“Giveaway”) is a promotional giveaway designed to encourage donors to register with Bloodworks for donations and to promote Bloodworks. The Giveaway is sponsored by Bloodworks (“Sponsor” or “Bloodworks”) with the principal place of the organization located at 921 Terry Avenue, Seattle, WA 98104. Sponsor will randomly select “Winner” (defined below) and “Prizes” as defined herein, will be awarded in accordance with these Official Rules (“Official Rules”). Tango is not affiliated with or sponsoring this Giveaway.

- 1. Eligibility:** In order to be eligible to participate in the Giveaway one must agree to be bound by these Official Rules which constitute a binding agreement. The Giveaway is open to legal residents of Washington or Oregon who are eighteen (18) years or older at the time of entry (“Entrants” or “Participants”). The employees of Bloodworks and all other companies, partners, advertising and promotion agencies associated with the design or execution of the Giveaway and the members of their immediate families (parents, grandparents, siblings, children, grandchildren and each of their respective spouses) and those living in the same household of each (whether related or not), are ineligible to enter. All Entrants in the Giveaway can opt out of participating in the Giveaway at any time by contacting Bloodworks and informing a Bloodworks representative or declining the “Prize” (defined below) if contacted by Bloodworks as a “Winner” (defined below in Section 4). For the avoidance of doubt, there is no obligation whatsoever to participate by any donor. Bloodworks will immediately cancel any participation at the request of any Entrant or donor. There may be additional documents for Entrants to complete in order to be eligible to win prizes in this Giveaway and such will be provided and requested when applicable by Bloodworks to said Entrants with instructions on any of the aforesaid.
- 2. How to enter:** To participate in the Giveaway, Entrants who meet the eligibility requirements as noted herein, must 1) submit their information via the Bloodworks website www.bloodworksnw.org/win AND 2) register to donate in-person at a Bloodworks donor center or Bloodworks mobile collection site/Pop-Up Donor Center (defined below) during the dates of May 1, 2024 – May 31, 2024 (“Giveaway Period”). Donors will receive one (1) entry for each donation during the Giveaway Period. Bloodworks will compile all of the names of eligible Entrants that meet the criteria within these Official Rules and will enter them in the Giveaway. All Entrants, i.e., those individuals entered in the Giveaway, must abide by these Official Rules to be eligible to win a “Prize” further defined below and to comply with all federal, state and local laws and regulations. *Bonus Entry Potential:* Bloodworks reserves the right at its discretion to add entries for Participants (or other additional incentives to promote participation in the Giveaway), such as double-entries for Participants that donate on specific dates. Entrants who do not provide complete, valid, and truthful registration information will not be eligible to win. Once registration is completed to the satisfaction of Bloodworks, the Entrant will be entered into the Giveaway as per these Official Rules. Limit one entry per week by Entrants (Sunday through Saturday) unless otherwise posted by Sponsor. As stated above, Sponsor reserves the right to incentivize Entrant participation in the Giveaway by increasing the entry amount per donation, and for the type of donation, provided it notifies the public in written form through updates to these Official Rules on its website and other social media platforms. For the avoidance of doubt, the criteria of eligibility for the Giveaway is such that Entrants must only register with Bloodworks to donate and meet the Official Rules requirements noted herein. Participation in the Giveaway is NOT predicated on Entrants being able to successfully donate with Bloodworks. Blood donation restrictions may apply. Registration to donate creates eligibility as long as Entrants are eligible in the other aforesaid areas of these Official Rules. Participants may not register with multiple names, addresses (including e-mail addresses) and any participant who attempts to enter with multiple names, addresses (including e-mail addresses) will be disqualified and forfeits any Prize won, in Bloodworks’ sole discretion. Entries in excess of the stated limits will be disqualified if they do not follow these Official Rules. Any potential Winner may be requested to provide Bloodworks with proof they are a legal resident of Washington or Oregon. Each Winner must agree to the Bloodworks use of his or her name, likeness, photograph, picture, portrait, voice, biographical information and/or any statements made by Winner regarding the Giveaway without additional compensation, obligation, or notice, for the purposes of publicity and promotion, worldwide and in perpetuity, in any and all forms of media, now known and hereafter devised, including, but not limited to, on-line, social media platforms, and in print.
- 3. Prizes and odds of winning:** Three (3) Grand Prize Winners will receive (only) one of the following as the Prize: One (1) \$1,000 prepaid gift card. Total value \$1,000.00 USD

LIMIT ONE PRIZE PER PERSON. Odds and chances of winning a Prize are based upon the number of eligible entries received with all Entrants having an equal chance of winning; Winner will be selected randomly. The prices above in US Dollars and are approximate. All other costs and expenses in connection with winning a Prize, including but not limited to, receipts and use of the Prize, are the sole responsibility of the Winner. The Prize may only be awarded upon proof of Entrants’ registration with Bloodworks. The Prize is not transferrable and must be accepted as awarded by Bloodworks. No prize in the Giveaway will be given in cash or may be redeemable or convertible into cash. The gift card must be redeemed from Tango. Bloodworks reserves the right, in its absolute and sole discretion, to make a substitution of a prize, to serve as the Prize, provided it is of equivalent kind or approximate value in the event of the unavailability of the Prize for any reason.
- 4. Winner Selection and Notification:** The one (1) Winner of the Prize (“Winner”) will be randomly selected from all eligible entries on or about June 15, 2024 and will be posted on Bloodworks’ website at www.Bloodworksnw.org. Winner must be legal resident of Washington or Oregon. Three (3) additional participants will be selected as alternates also at random, “Alternative Winners”, in the event the Winner randomly selected is unable to accept the Prize for any reason(s) whatsoever. Bloodworks will notify the Winner by phone call or email (at Bloodworks’ selection based on the registration information provided). Winner shall have forty-eight (48) hours from the time Bloodworks has placed a notification phone call and/or from the time Bloodworks has sent a notification email to respond to Bloodworks and accept their Prize with proof of identification, or, at Bloodworks’ option, the next-in-line Alternative Winner will be chosen and notified and awarded the Prize. A person may not win more than ONE (1) Prize in this Giveaway.
- 5. Conditions; RELEASE:** (a) Winner will be responsible for any federal, state and local tax liability and must upon request provide Bloodworks with their social security number and any other applicable information for the purpose of preparing IRS Form 1099. Any action or litigation concerning this Giveaway shall take place exclusively in the federal or state courts sitting in Seattle, Washington, and each Entrant expressly consents to the jurisdiction and venue in such courts and waives all defenses relating to jurisdiction or venue in such courts. Arbitration shall proceed solely on an individual basis without the right for any claim to be arbitrated on a class action

basis or on bases involving claims brought in a purported representative capacity on behalf of others. The arbitrator's authority to resolve and make written awards is limited to claims between Winner and Bloodworks alone.
